NURSING ENTRANCE EXAMINATION TEAS V SCHEDULE FOR 2011-2012

All applicants seeking admission to the Associate Degree Nursing/Practical Nursing program(s) offered by Sampson Community College must complete the TEAS V (Test of Essential Academic Skills V) and achieve a proficient, advanced, or exemplary level before admission to the programs can be considered. Applicants may take the TEAS V only after all prerequisites have been completed with a grade of "C" or better. *Official transcripts must be on file in the Admissions Office before students will be allowed to schedule a TEAS testing date.*

Prerequisites:

- High school or college Biology (BIO 110 or higher) with respective labs
- High school or college Chemistry (CHM 092 or higher) with respective labs
- Algebra (MAT 070)

Each of the above courses should be completed within the past 10 years (high school courses within 10 years by graduation date) with a letter grade of C or better.

- Completion of a North Carolina approved Certified Nurse Aid I program.
- Applicants must also be a certified nursing assistant listed on the North Carolina Nurse Aide I Registry with no substantiated findings
- CPR certified by American Heart Association or American Red Cross.

Applicants for fall admission **must** complete the TEAS test by **March 15, 2012**. The college reserves the right to extend the application/testing period when warranted. Students who lack **only one** of the above prerequisites or requirements may test after March 15 at the college's discretion.

Students will not be allowed to take the test without showing proper identification and an original receipt issued by SCC.***
